## Appendix 1

### Overview

The European Cleft Organisation is a Dutch based NGO founded in 2008 with full charity tax status (ANBI) in the Netherlands. Its principle aim is to improve cleft care in Europe for all children and adults born with clefts. There is currently a huge disparity in care across Europe and in some countries children born with clefts are needlessly placed in orphanages.

#### Values

We believe all children and adults born with clefts must have:

*Equal Opportunities* The right to a life full of equal opportunities without discrimination.

## Quality Care

The right to access quality care to experience life to their fullest potential.

## Patient-centred care

The right to receive care within a whole person approach which engages from a holistic and multidisciplinary perspective.

#### Evidenced-based

The right to benefit from interventions rooted in sound research and best practices.

#### Mission

The European Cleft Organisation (ECO), through training initiatives and a network of partners, creates environments to ensure every family and all children affected by clefts have life-long access to quality care and equal opportunities within our European societies.

# Vision

Every child with a cleft has lifelong access to quality care and equal opportunities throughout Europe.

# Approach

- Awareness Raising communicating information which improves understanding of the challenges faced by families, children and adults with a cleft.
- Policy Change dialoguing with government stakeholders to formulate initiatives which increase access
  to quality health care and equal opportunities for families, children and adults with a cleft.
- *Capacity Building* through training, strengthening organizations'/hospitals' ability to deliver quality health care and support for families, children and adults with a cleft.



*Collaboratio* n – networking with organizations to exchange information, share resources, and enhance each other's capacity to advance the cause of for families, children and adults with a cleft.

#### Achievements to date

The European Cleft Organisation has two paid staff member (Executive Director and Training Manager) and the outputs to date have been highly impressive given this lou, investment in human resources:

- \* Nine-year operational management of pilot programmes in Bulgaria, developing a national centre of excellence in cleft care in Plovdiv, working alongside a local partner. Training and developing networks of nurses and speech therapists. Reducing abandonment of babies with clefts.
- \* Development of European guidelines in early cleft care (with European Committee for Standardisation (CEN, Brussels see below).
- \* Facilitating nurse training in Bulgaria, Latvia, l,ithuania, Rornania, Setbia, Spain and overseeing development of RomaniaCleft, the first professional cleft association in Romania. Greece and Slovenia have requested training for 2017 and we are currently developing a more rigorous partnership training agreement with countries to ensure new skills are implemented in day to day practice.
- \* Development of web directory for cleft services in Europe (European Cleft Gateway) a resource for cleft professionals and patients. Currently over 100 centres represented and. Thanks to a grant from the European Science Foundation (EUROCleftNet programme) the Gateway will be extensively rebuilt during 2017 to make it more user friendly and accessible to clinicians, researchers and patients alike. There has been interest in this from some major cleft organisations globally and with further funding it may provide a model that could be used beyond Europe.
- \* Partners in five EU-funded collaborations COST 'Appearance Matters', ESF 'EUROCleftNet', Erasmus Plus 'When Looks get in the Way', 'Face Value' and 'IHEM' (health education module). At the end of 2016 we submitted a major application for a new and ambitious COST initiative looking specifically at equal access to cleft care across Europe and in 2017 we plan further Erasmus applications, including a specific proposal around the development of a cleft nursing training programme.
- Coordinated 2 major European conferences Plovdiv 2012 (research), Bucharest, 2015 (specialist nursing)

#### Approval of European guidelines in cleft care

In 2015 member bodies of the European Committee for Standardisation (CEN) approved the guideline report CEN/TR 16824'Eaily care services for babies born with cleft lip and/or palate'. The process began in 2011 and the final report has been the result of input from stakeholders in Austria, Belgium, Bulgaria, Estonia, Finland, France, Germany, Lithuania, Spain, Romania and the UK. The process was initiated and coordinated by ECO and the result is a document that can act as a model for early cleft care in countries where no protocols exist. In the longer term this document may have global impact.

#### **Board of Directors**

There were some changes to the Board of Directors in 2016. Founding Member Gareth Davies stood down from his role of Chair and was replaced by long-standing board member, Nigel Mercer, cleft surgeon and former President of the British Association of Plastic, Reconstructive and Aesthetic Surgeons (BAPRAS). Emma Southby also stood down after being interviewed and appointed as the charity's first Training Manager. Julija Radojičić, a specialist cleft orthodontist form Serbia, joined the board as a representative of our partner projects.



#### Challenges going forwards

To build on our successes to date and to be able to deliver training to those countries that have requested it, ECO took on its second staff member at the end of 2016. Emma Southby joined us as Training Manager and will develop and extend training programmes across Europe. Her first major task will be to apply for EU funding through the Erasmus programme for specialist nurse training. Should this be successful she will lead partner countries over two years in the development of a downloadable multi-language dedicated training programme in early cleft care.

To sustain the Training Manager post in the longer term ECO needs to develop fundraising strategies on many fronts and build relationships with a wider network of potential funders. There is a need to raise the charity's profile in its home country, the Netherlands and we envisage working more closely with health professionals in the Netherlands during 2017. This will be helped by the fact that the new EU-driven European Network for Craniofacial anomalies and ENT disorders is being coordinated from the Children's Hospital in Rotterdam. ECO is on the Management Board of this new network. Secondly, the 2018 European Craniofacial Congress is being hosted by the cleft team in Utrecht and we will be liaising with Congress organisers in the planning of the event. The cleft team in Nijmegen has also recently expressed an interest in our nurse training activities. All these connections should serve to strengthen our profile and raise our visibility in the Netherlands.
